## NON-PUBLIC SCHOOL TRANSPORTATION REQUEST

New York State Education Law requires that a written request be submitted **each year** to the Board of Education by the parent or legal guardian of an eligible pupil attending a non-public school for which transportation is desired. *Only one form is required for children attending the same non-public school*. This request is to be sent to the transportation department **no later than April 1**<sup>st</sup>\* preceding the beginning of the next school year. If families move into the district later than April 1<sup>st</sup>, the request must be made within thirty days after establishing residency in the district.
